





Load of Chickens **Destroyed by Fire** 

WOODBRIDGE --- No, you were not mistaken when you thought you smelled the odor of roasted chicken when you drove along Route 35 in the vicinity of Flood Street this morning.

For, at 1:50 this morning a truck load of chickens, valued at \$4,000, was destroyed by fire at that spot and as a result scores of Brooklyn housewives will be minus their Sunday dinners.

Harry Rubin, 706 Belmont Avenue, Brooklyn, owner and driver of the truck, told Officers William Romond and William Majoros he was headed toward New York with his load of poultry, when suddenly flames began shooting out of the motor into the cab of the truck. He said he slowed the vehicle and before he could stop it completely he was forced to jump to save his life.

As he leaped to safety, Rubin related, the truck turned over and he was forced to stand by helplessly and watched the chickens die By the time Woodbridge Fire Company was called and arrived on the scene the truck and the chickens were destroyed. Rubin valued the truck at \$1,800.
